

# INSTA1000 **PROMOTION** REGULATIONS

## §1

### Terms

- Whenever the Regulations mention:
  - **Regulations** - shall mean the regulations defining the rules of participation in the INSTA1000 Promotion,
  - **Organizer** - it means the company TASKOMONT sp.z o.o. with its registered office in Opole, ul. Ozimska 68/24, 45-370 Opole, with REGON number: 362007817, number KRS: 0000567049 and NIP (tax identification number): 754-30-95-729,
  - **Participant of the promotion** – it means a person placing an order for products covered by the promotion, while meeting the promotion rules set out below.

## §2

### Promotion rules

- INSTA1000 promotion runs from **12/12/2019** to **15/01/2020**.
- A condition of using the promotion is placing an order by e-mail or phone with the password **INSTA1000**
- Product prices.

  - The price of each coffee table covered by the **INSTA1000** promotion (listed above) is PLN **3500** gross including VAT 23%
  - For foreign sales the price is **660 €** net
- A condition for concluding a Sales Agreement is placing an order and paying the full amount of the order to the account provided in the Order Form available on the website at [www.znammi.pl](http://www.znammi.pl) by **15.01.2020r.**

- Delivery cost.
  - The cost of delivery in Poland is covered by ZNAMMI.
  - The delivery cost does not include the submission and setting up of the product
  - Delivery outside of Poland is priced individually.
- The remainder of the General Terms and Conditions of Sale (GTCS) and the Warranty Terms and Conditions set out at [www.znammi.pl](http://www.znammi.pl)
- The number of products is limited. The order of orders is decisive, i.e. the date of payment of the full amount to the account given in the Order Form available on the website [www.znammi.pl](http://www.znammi.pl)
- The organizer will post information on [www.znammi.pl](http://www.znammi.pl) on the day on which the number of promotional prizes allocated for the INSTA1000 Promotion will be expired.
- The order of implementation of the Order Forms will be determined on the basis of the deadline for the forms to be sent to the Organizer
- Participant of the INSTA1000 promotion can buy one promotional coffee table at the promotional price.
- INSTA 1000 promotion cannot be combined with other promotions and special conditions addressed to distributors
- The deadline for orders is January 15, 2020. The order processing time is 14 calendar days and will be counted from the moment the order is accepted by the organizer and the availability of prizes in the INSTA1000 Promotion
